A \$500 deposit for each person, per session (including day campers) must accompany the application form to secure a place at camp. 50% of Tuition balance is due no later than 60 days prior to the start of session. Remaining balance is due no later than 30 days prior to the start of session. Any discounts (early bird, sibling, multi-session) are honored ONLY if full balance is paid on time.

A non-refundable processing fee of \$200 will be retained if you have to cancel your reservation, and do so 30 days prior to the start of session. Within the 30 day period, the full deposit of \$500 will be retained, and the balance of the tuition will be refunded only if the place can be filled from our waiting list. In the event that the place cannot be filled, the full tuition is forfeited.

I agree that in the event this application is accepted and a place reserved for my child at U.S. Elite Camps, my child will remain in camp until the end of the session unless he/she is dismissed by the camp directors for misconduct or for cause considered sufficient by the camp directors. I understand that there will be no refund of camp charges paid for the time reserved in the event of dismissal. U.S. Elite Camps, Inc. assumes no responsibility for loss or damage to personal property of athletes. Individuals who damage property may be billed for replacements/repairs.

It is my desire that my child be enrolled, as indicated above, subject to the above conditions.
